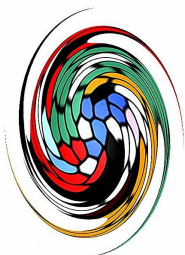

John W de Gruchy, an ordained minister of the United Congregational Church of Southern Africa, has taught in the Department of Religious Studies at the University of Cape Town since 1972. De Gruchy is recognised nationally and internationally, primarily for his work on both the theology of Dietrich Bonhoeffer and the role of the churches in pre- and post-apartheid South Africa. He has in addition been formally recognised as one of South Africa's leading social scientists. He has published widely, authoring, co-authoring and contributing to numerous books and articles. Among de Gruchy's notable publications are *The Church Struggle in South Africa*, *Christianity and Democracy*, and *Christianity, Art and Transformation*.

He was awarded the illustrious Karl Barth Prize in 2000 by the Evangelical Church of the Union in Germany for his theological work on justice and reconciliation in South Africa, followed by honorary doctorates from Chicago Theological Seminary and Rhodes University.
